Eligibility

a) Associate Member:

To Qualify as an Associate Member, the applicant must be qualified as a graduate or equivalent. With additional professional or management qualifications, and should have reached the position of senior management in any organisation. The Committee should be satisfied that the applicant is fit and sound to meet the objectives of the Institute.

An Associate Member is entitled to use the designation AM.IOD after their name.

b) Member :

To Qualify as a Member in addition to the requirements for an "Associate Member", the applicant should be holding a responsible position in business, industry or government (equivalent to a Director), for at least three years and should preferably have a DIN number.

Member is entitled to use the designation M.IOD after their name.

c) Fellow :

To Qualify as a Fellow, one must satisfy certain additional requirements than a Member, the applicant should have been a Director in a listed organisation or a private / public limited company, for a minimum period of three years or have over ten years of business experience at senior level.

A Fellow is entitled to use the designation F.IOD after their name.

INSTITUTIONAL MEMBERSHIP

Eligibility

The organisation should fall under one of the following categories:

a) Large Enterprises

(Annual Turnover Rs.500 crore and above):

Large Enterprises will be entitled to nominate upto 4 senior executives as Members, who could be replaced, as and when required.

b) Small & Medium Enterprises (SMEs)

(Annual Turnover below Rs. 500 crore)

SMEs will be entitled to nominate upto 2 senior executives, as Members, who could be replaced, as and when required.



HOW TO APPLY:

1. Fill up online Membership Form on **www.iodglobal.com**, enclose a CV/Company Profile and pay the Entrance Fee.
2. CV/Company profile will be reviewed by the Membership Committee to decide the eligibility and category.
3. Once Membership application is approved by the Membership Committee, applicant is required to submit the Membership Fee.

TERMINATION OF MEMBERSHIP

- A person may cease to be Member of the Society:
 - On tendering his/her resignation in writing to the President of the Society; or
 - On his/her death; or
 - If the person has applied to be adjudicated insolvent or is an undischarged insolvent; or
 - If the person has been convicted by a Court or Tribunal of competent Jurisdiction of any offence involving moral turpitude; or
 - If the person found to conduct himself in a manner unbecoming of a Member of the Society by two-thirds of the other Members present and voting at a meeting of the Society called for the purpose of considering the conduct of the said member
- The Governing Council may at its sole discretion and on subject to such terms and conditions as the Council may, in its sole discretion consider appropriate, readmit any member whose membership has been terminated pursuant to this Regulation.
- In case of termination of Membership, such Member shall be communicated the reasons for termination, in writing.
